The school shall cease accepting completed applications for admission on	13 <sup>th</sup> November 2025 at 12.00 noon
The latest date by which applicants will be notified of the decision on their application is	4 <sup>th</sup> December 2025
The period within which applicants must confirm acceptance of an offer of admission is	10 days from date on letter of offer by 12.00 noon

Failure to accept an offer within the prescribed period will result in the offer being withdrawn.

Note: the school will consider and issue decisions on late applications in accordance with the school's admission policy.

2. Children who wish to transfer from a recognised school to Holy Family Junior School.

DOCUMENTATION REQUIRED FOR ALL ADMISSION APPLICATIONS

1. Original Birth Certificate/Adoption Certificate. (not a photocopy)  
All pupils who are accepted for enrolment will be registered as per the name on their birth certificate.
2. Child's PPSN
3. TWO original items as proof of address, issued within 3 months:
  - one must be a gas/electricity bill \*\*\* AND
  - any one of the following: Statement from Bank/Building Society/Credit Union, Letter from Dept. Social Protection/Revenue. Other official correspondence from an Irish State Agency.(not required in the case of siblings who are currently enrolled Holy Family Schools)
4. Eircode
5. E-mail addresses for parents/guardians

\*\*\*Where the applicant cannot present the stipulated gas/electricity bill, a gas/electricity bill with the householder's name where they are living, together with a letter from a Peace Commissioner / Commissioner of Oaths, confirming that the address given is the primary residence of the child/applicant. This letter must be dated within the previous 3 months of the date of application.
